ARTICLES OF AGREEMENT AND BY-LAWS
of the
MASSACHUSETTS CHIEFS OF POLICE
ASSOCIATION, INCORPORATED

Organized November 5, 1887
Incorporated May 2, 1949

ARTICLES OF AGREEMENT OF ASSOCIATION
AS AMENDED

Mutual aid and sympathy is considered an important factor in the successful pursuit of business, social and fraternal organizations. In no case is this more clearly illustrated than in the discipline and management of police. Prompted by a desire to further the interests of the different police departments, it is considered desirable that there should be an association of the heads of police organizations throughout the Commonwealth of Massachusetts in order that they may meet on stated occasions to advance social and fraternal intercourse; interchange views regarding the best methods of preventing crime; discuss crimes and criminals, police discipline and kindred subjects and such other matters as the interests of their occupations would make it right and proper for them to take action upon as an organized association.

It shall be the duty of this Association to aid and assist its members in the discharge of their duties, give counsel and advice on all important questions and assist each other in all matters relating to the welfare of the Association or individual member thereof.

Mission Statement

The MCOPA shall advance professional police services; promote enhanced administrative, technical, and operational police practices; foster cooperation and the exchange of information and experience among police leaders and police organizations of recognized professional and technical standing throughout the Commonwealth.

We shall champion the recruitment and training of qualified persons in the police profession and encourage all police personnel statewide to achieve and maintain the highest standards of ethics, integrity, community interaction and professional conduct.

ARTICLE I

NAME. This Association shall be known as the Massachusetts Chiefs of Police Association, Incorporated.

MOTTO. The motto of this Association shall be: "In Unity There Is Strength."

EMBLEM. The official emblem of this Association is of circular design and blue and white in color, with the word "Massachusetts" on the top half of the circle, the words "Chiefs of Police" across the center, the word "Association" on the lower half of the circle, the silhouette of the Commonwealth between the word "Massachusetts" and the words "Chiefs of Police" and the lower-half of a complete sunburst between the words "Chiefs of Police" and the word "Association."

ACTIVE MEMBERSHIP. Whoever shall hold the title of Chief of Police in a city or town in Massachusetts, the Superintendent of Police of Lowell, the City Marshall of Newburyport, the Police Commissioner of Boston, the Superintendent of the State Police, and the Chief of the Massachusetts Bay Transportation Authority Police. A Public Safety Commissioner in a Massachusetts city or town, performing the duties of a Chief of Police on a full-time basis and with the power and authority of a certified full-time police officer to make arrests and a duly appointed acting Chief of Police may be eligible for active membership with voting privileges upon recommendation of the Membership Committee and majority vote of the Members. Further, any person applying for active membership who does not hold one of the above-stated titles shall have his or her application referred to the Membership Committee for investigation and recommendation and thereafter the recommendation shall be referred to the Members for approval or rejection by majority vote. Each police department or law enforcement agency shall be entitled to one active membership only.

The base dues for departments listed above shall be as set forth by population per calendar year payable in the month of January as shown in the table below. Any member who shall neglect to pay his dues within ninety (90) days from the first day of January shall, after notice by the Executive Director, be reported to the Association for appropriate disciplinary action by the body. Dues shall not be proportionable.

	Base Dues
Population of less than 10,000	\$450.00
Population of 10,001 to 20,000	\$550.00
Population of 20,001 to 49,999	\$700.00
Population of 50,000 or more	\$850.00

The base dues for the Special Agent in Charge of the Boston Office of the Federal Bureau of Investigation and other similar heads of federal law enforcement agencies shall be Five Hundred (\$500.00) Dollars.

LIFE MEMBERSHIP. Upon the retirement of an active member of the Association after five (5) years, unless waived upon recommendation of the Membership Committee and majority vote of the members, as an active member of the Association for any reason whatsoever except for disciplinary reasons, and upon application by the active member, such individual may be eligible for life membership in the Association upon recommendation of the Membership Committee and majority vote of the Members. A Life Member can take part in the discussions that come up at any meeting. A Life Member shall be entitled to vote, serve on any committee and be exempt from payment of dues. If an active member is holding office an Elected Officer in the Association at the time of his or her retirement, he or she shall continue to hold said office until his or her term expires. If an active member is a member of the Executive Committee in the Association at the time of his or her retirement, the county he or she represents, may replace their regional representative at the next scheduled general membership meeting. For purposes of this paragraph, "retirement" is defined to mean: leaving office for reasons of disability, longevity or superannuation.

HONORARY MEMBERSHIP. The following persons shall hold honorary membership in the Association during their term of office: Governor, Lieutenant Governor, Attorney General, President of the Senate, Speaker of the House, and the Secretary of Public Safety. In addition, any person of marked distinction who has shown an unquestionable interest in the welfare of the Association and its purposes as set forth in its articles of agreement may be eligible for honorary membership. Such application for honorary membership shall be made to the Membership Committee in writing by the Chief of Police of the city or town in which the candidate resides and one (1) other Chief of Police setting forth in detail all relevant personal data of the applicant and the Membership Committee shall make its recommendation to the Members for either acceptance or rejection by majority vote. Any such member may take part in the discussions that come up at any meeting upon permission of the presiding officer and shall be exempt from the payment of dues, but cannot hold office in the Association and is not entitled to vote.

ASSOCIATE MEMBERSHIP. Any person, firm or corporation may be eligible for associate membership. Dues for such membership shall be one hundred fifty (\$150.00) dollars per calendar year payable in the month of January. Dues for the year shall accompany each application, and such dues shall not be proportionable. Any such member, or if the membership is held by a corporation, a corporate officer or its general manager, may take part in the discussions that come up at any meeting upon permission of the presiding officer, but cannot hold office and is not entitled to vote. Applications for associate membership shall be made to the Membership Committee in writing by the Chief of Police of the city or town in which the candidate resides and in the case of a corporation membership, the Chief of Police where the corporation has its principal place of business. The application shall set forth in detail all relevant personal data of the applicant and the Membership Committee shall make its recommendations to the Association for either acceptance or rejection by majority vote.

SUSTAINING MEMBERSHIP. Any person may be eligible for sustaining membership. Dues for such membership shall be set from time to time by the Board of Directors. Any such member cannot hold office, is not entitled to vote and may not take part in discussions at any meeting.

ARTICLE II

MEMBERSHIP APPLICATIONS: (a) All applications for membership, active or otherwise, shall be considered by the Membership Committee at its next regular meeting following receipt of the application, voted upon by a majority of its members present at the next regular meeting of the Committee and referred to the Association for action, by majority vote of the members present, at its next regularly scheduled monthly meeting. The Membership Committee shall prepare the applicable membership forms for the various membership classifications, as may from time to time be changed, subject to the approval of the Board of Directors. Criteria for membership shall be established by the Membership Committee including that the person is in good standing in the community and of good moral character. The Membership Committee shall be entitled to refer the application back to the sponsors if the same is incomplete, for more definite response or for additional information and shall have the right to interview all nominees for Honorary Membership or Associate Membership.

(b) Recognizing that the office of Chief of Police, Acting Chief, Commissioner of Public Safety or similar position executing the duties of Chief of Police involves the need for public confidence, trust and unquestioned integrity, it is recognized that a procedure of internal discipline is required. Accordingly, any member of the Association engaging in conduct unbecoming a member of this Association or in contravention of the public trust imposed on him may be disciplined, after review, by the Board of Directors. The Membership Committee, upon receipt of charges against a member of the Association shall fully investigate the charges and shall notify the member charged and shall hold a hearing before the Board of Directors, in Executive Session, upon the charges made. All parties shall have the right to be represented by a person of their choosing, to present evidence, to confront and cross-examine witnesses. After due deliberation, the Board of Directors shall determine, by majority vote, if the member charged has violated his public trust and confidence by engaging in the conduct or action charged and shall so notify the member of its decision and the disciplinary action assessed, which may include revocation of membership in the Association. Any member aggrieved by a decision of the Board of Directors shall have the right to appeal that decision to the Members at their next regularly scheduled monthly meeting and the Members shall either accept or reject the decision of the Board of Directors by majority vote. On any other matter directly affecting an Active member, no action shall be taken until such member has an opportunity to be heard.

ARTICLE III

ELECTED OFFICERS. The elected officers of this Association shall consist of a President, 1st Vice-President, 2nd Vice-President, 3rd Vice-President, Sergeant-at-Arms, and an Executive Committee of seventeen (17) members, of which one shall be the immediate retiring President of the Association, one shall be a Life Member, one shall be from the following areas: one from Barnstable and The Islands (Dukes and Nantucket counties), and one each from Berkshire, Bristol, Essex, Franklin, Hampden, Hampshire, Norfolk, Plymouth, and Suffolk counties, and two each from Middlesex and Worcester counties, and one selected by the Major City Chiefs of Police Association.

Only Active and Life Members of the Association of a particular area or county shall be eligible to vote for candidates for Executive Committee from that area or county. All the elected officers and the Executive Committee shall constitute a Board of Directors. Only an Active Member who is a Chief of Police in a city or town, the Superintendent of Police in Lowell, the City Marshal of Newburyport, the Police Commissioner of Boston or the Chief of the Massachusetts Bay Transportation Authority shall be eligible for election to an office in the Association except a Life Member to the Executive Committee.

The Board of Directors shall have the control of the management of the Association including the ways and means for carrying out the objectives of the Association subject at all times to the wishes of the members present at any regular meeting.

At the annual October meeting, the President shall appoint a Nominating Committee of three (3) members, whose duty it shall be to nominate members for the various offices who are to be voted on at the following November meeting.

The officers shall be elected by ballot at the annual November meeting and shall assume the duties of their respective positions at the annual December meeting.

ARTICLE IV

MEETINGS. Regular meetings of the Association shall be held at such times and places as may be decided upon by the Executive Board. In no event will there be less than four (4) meetings per year. The location of such meetings, if not specified by the Executive Board, may be determined by the Executive Director. In the event of inclement weather, the President, after consultation with the Executive Director, may cancel or postpone the meeting. The President, with approval of a majority of the Executive Board (which may be secured without a meeting), may cancel meetings, provided notification is made to the general membership at least twenty (20) days in advance.

Special meetings may be called at the option of the President. The President shall, when requested by fifteen (15) or more members, call special meetings provided that the requests state the business to be acted on.

At any regular or special meeting, thirty (30) members shall constitute a quorum for the transaction of business.

Closed meetings for active and life members shall be confined to the business at hand.

At each meeting, the Chief who is host for the day, may invite a chaplain of any religious denomination to give the invocation.

ARTICLE V

OFFICERS' DUTIES. The President shall preside at all meetings of the Association, preserve order and decorum and decide all questions of order, subject to the body. He shall have a vote on all questions.

The 1st Vice-President shall be the Acting President in the absence of the President. The 1st Vice-President shall be the President if a permanent vacancy occurs by the death or resignation of the President. If a permanent vacancy occurs in any of the other Officer positions, the officeholders shall move up in the order of ascendancy to President. If a permanent vacancy occurs in the position of Sergeant-at-Arms within the first six months of the calendar year, a special election shall be called to fill the vacancy.

The Sergeant-at-Arms shall be responsible for assuring that all persons present at the meetings are members in good standing or guests of members.

ARTICLE VI

APPOINTED OFFICER. There shall be an Executive Director who shall be appointed by the Board of Directors from year to year as the Board shall determine and who shall have no vote at Board meetings. The Executive Director shall attend all meetings of the Association, issue notices of meetings, keep a true record of all proceedings, receive all monies due the Association and keep an account between the Association and its members, issue all drafts in behalf of the Association and carry out other duties determined by the Board of Directors. He shall submit to the Board of Directors a certified public accountant's audit of the financial condition of the Association within sixty (60) days of the end of the calendar year. He shall also submit a monthly report of the total cash received and disbursements made for the preceding month. He shall be bonded for an amount to be determined from time to time by the Board of Directors. He shall be entitled to such compensation for his services as the Board of Directors may from time to time determine.

ARTICLE VII

COMMITTEES. Within thirty (30) days of assuming office, the President shall appoint the following committees and such others as he deems necessary:

Legislative - a committee of no less than nine (9) members, with the Chairman designated by the President, whose duties shall be to have legislative bills prepared for the Association, to file legislation for and represent the Association before the Great and General Court, and to keep the Association informed of all legislation affecting police.

Membership - a committee of five (5) members, including the 2nd Vice-President as Chairman, whose duties shall be to seek active members for the Association, to recommend or reject applications for honorary or associate membership and to annually review the honorary and associate membership with the Executive Director making such recommendations as they deem necessary. Such recommendations shall be voted upon at the annual March meeting of the Association.

Program - a committee of five (5) members including the 3rd Vice-President as Chairman, whose duties shall be to make complete arrangements for all regular and special meetings of the Association and together with the Executive Director shall provide the program for such meetings.

ARTICLE VIII

CHANGE IN BY-LAWS. These by-laws may be amended, repealed or suspended only by a two-thirds vote of the members of the Association present and voting at the annual meeting held for the election of officers.

Any proposal for such amendment, repeal or suspension of the by-laws shall be in writing (which includes via e-mail, electronic, fax or other means), filed with the Executive Director at least sixty (60) days prior to such meeting and shall be signed by the member or members making such proposal. The Executive Director shall immediately forward the proposal to the Chairman of the By-Law Committee and to the members of the Executive Board. The By-Law Committee and the Executive Board shall send their recommendations, if any, to the Executive Director who shall make them known at the meeting. The Executive Director shall send written notice (which includes via e-mail, electronic, fax or other means) containing the proposed amendment, repeal or suspension of these by-laws to each active and life member not sooner than twenty-eight (28), nor less than fourteen (14) days before the meeting at which the membership will be asked to consider the amendment, repeal or suspension, along with any comments received from the Executive Board and/or By-Law Committee. At the Association meeting, the membership may entertain and adopt amendments to the original proposal so long as they affect the same topic area or by-law provision contained in the original proposal.

ARTICLE IX

STATEMENTS OF POLICY. All releases and statements of any information concerning the policy of the Association shall be issued by the President or his designee.

ARTICLE X

PUBLIC OFFICE ENDORSEMENTS. An Active or Life Member who wants the Association to endorse a named candidate seeking election or reelection to a designated public office, shall in writing submit a request to the Executive Director, who shall send written notice of the request to each Active and Life Member not less than thirty (30) days prior to the next scheduled Association Meeting. First, the Association shall decide whether or not it wants to endorse any candidate for the designated office. Approval shall require a two-thirds majority of the Active and Life Members present and voting. If successful, then the Association shall vote on endorsement of the named candidate. Approval shall require a majority of the Active and Life Members present and voting.
